From the President - Summer Leadership Experiences in Alexandria and Castine

Greetings Counselors!

I hope all of you had a great summer! I was camping at Sebago Lake over the Labor Day weekend and had the opportunity to hear Allagash stories old by a park affiliate. Those wonderful stories reminded of Maine's beauty as well as the diversity of people we serve. In July, I met with other branch leaders at the ACA Leadership Conference in Alexandria and had the opportunity to reflect on issues that impact those people as well as the practice of professional counseling in Maine. Over one hundred and thirty professional counselors in leadership roles had the opportunity to converge on Capital Hill in order to advocate for our profession. Terry Mitchell and myself, representing MeCA, met with the staff of Senator's Snowe and Collins, as well as Representative Michaud, to discuss three key ACA legislative issues that impact our profession and our clients. Those issues briefly summarized are:

1. Continued funding for the Elementary School Counseling Program (ESSCP)

The ESSCP provides competitive grants to schools and is the only Department of Education Program that is focused on support for school counseling programs and the implementation of school counseling services. As you well know, research shows that implementation of school counseling programs significantly impacts the life of our students. ACA is requesting that Congress maintain an appropriation of at least \$52 million for continuation of existing programs.

2. Medicare, Outpatient Mental Health Services, and Coverage of Licensed Professional Counselors

Data indicates that access to mental health services in the Medicare program is a significant problem for elders and others who receive that benefit. The positive impact of mental health services on chronic disease measures is well known. However primary care providers report that it is often very difficult to find services for their patients. Medicare

covers mental health services when provided by psychiatrists, psychologists, clinical social workers and advanced practice nurses. But despite comparable training, and in some cases, more training, LCPC's are not reimbursable under Medicare. ACA would like Senators to cosponsor s. 604, the "Seniors Mental Health Access Improvement Act of 2011", that would cover LCPC's. Additionally, a House companion bill should be included.

3. Licensed Professional Counselors continue to be Excluded Being Hired by the VA

In December of 2006, both Congress and the President enacted legislation that explicitly recognized Licensed Professional Counselors within the VA. Even though the VA adopted standards in response to the legislation, Licensed Professional Counselors have been shut out. In 2012, the VA posted 940 positions for social workers and only 49 for LCPC's. Veterans are thus deprived of the services that can be provided by clinical mental health counselors. Both the need as well as factors like the high suicide rate among recent veterans is a major concern. Senators Snowe and Collins have been extremely active in support of Maine's veterans. Representative Michaud has been very supportive of LCPC's in the VA and received official acknowledgment from ACA in a letter delivered by Executive Director Richard Yep during our visit with the congressman's staff. ACA would like Congress to exert pressure on the VA to fully incorporate LCPC's into its structure.

These issues as well as others impact the way in which our identity as professional counselors is evolving. The main learning for me from the Capital Hill experience is that in order to "be seen" we need to speak up. Although most legislative staff knew about professional counseling, there were some who were not familiar with the range of services we provide. We need to continue to speak up! Public Policy Update

Below is a listing of the bills relevant to the counseling profession that were heard during the last legislative session. Two of the bills were supported by MeCA with written testimony. The bills were LD 1760 - An Act to Ensure Notification to Victims of Domestic Violence, Sexual Assault and Stalking When Defendants Are Released on Bail), and LD 1857 – An Act to Enhance the Protection of Social Service Home Visitors. LD 1760 was passed and signed by the Governor, while LD 1857 did not make it out of committee.

Using Knowledge of Neuroscience in the School Counseling Session

Given the growing research and emerging media coverage about how one's brain can be "re-wired" as a result of things like trauma, psychotherapy and meditation, it behooves all school counselors to have a basic understanding of neurobiology. However, this can be a daunting task, even for the most scientifically savvy counselor. Reading books written for psychotherapists about neuroscience is one way to begin digesting the information.¹

Going to seminars about the brain and studying two and three dimensional brain models are other ways to absorb this complicated material. But once you know the facts, how are you supposed to make use of them? Integrating simple, concrete neurobiological concepts using fun props with teachers, students and their caretakers in the classroom or school counseling session is an effective way to start.

Having intense feelings and reactions can be confusing, making children and their caretakers insecure and apprehensive. By showing them in a simple, objective way, what is going on in their brains, and how it is all connected to the other parts of their body, just enough distance is provided to start discussing their issues in a new way, from a more objective perspective. Students with ADHD, problems with anger, anxiety, or other challenges can all benefit from learning what is going in their brains when they are struggling, as well as how positive coping skills can help. Doing so with the use of simple props can be engaging, fun, and memorable.

Connie McVey, LCSW, a psychotherapist at Acadia Hospital in Bangor, has been integrating neurobiology in play and traditional therapy sessions for several years and has presented on this topic at workshops throughout Maine. She will be offering a workshop entitled "Playing with the Brain: Integrating Neurobiology, Play therapy and Neurolinguistic Programming" at the Maine Association for Play therapy Conference on September 15th at Acadia Hospital. Neurolinguistic programming is a sensory based approach to therapeutic change and enhanced learning, and can easily be integrated into counseling and classroom settings.

Another workshop offered at the September 15th conference will be "Using the Moving Stories Play Therapy Method in Clinical Groups" by Robyn Greene, LCPC. Moving Stories is a method that has been successful in public classrooms; therefore, teachers, in addition to school counselors are encouraged to attend this session. Another workshop offered will be "Play Therapy and Trauma" by Grace Brace, LCSW. Grace will present effective play therapy techniques for children and families who have experienced trauma. "Play Therapy and Neurofeedback" by Susanne Carroll Duffy, Psy.D, RPT-S will use a case study of a child with ADHD and OCD to demonstrate how play therapy and neurofeedback may be integrated. Both mental health and academic professionals will benefit from learning about this cutting edge approach to helping children succeed in and out of the classroom.

Maine Congressman Michaud Pushes VA on Hiring Counselors

ACA is pleased to announce that it has gained a champion in efforts to establish more mental health clinician positions for licensed professional counselors within the Veterans Administration (VA) healthcare system. In June, Congressman Mike Michaud (D-ME), the ranking member on the House Veterans' Affairs Subcommittee on Health, submitted a letter to Secretary for Veterans Affairs Eric Shinseki that calls on him—and the VA as a whole—to begin to hire counselors in the VA medical system.

Congressman Michaud inquired about the steps the VA is taking toward hiring counselors in clinics and hospitals, and how it intends to fill the 1,600 new mental health clinician positions it created in April of this year. The letter points out that the VA has been empowered by Congress to hire LPCs for almost six years. Representative Michaud's letter is posted on ACA's website. The VA has not yet responded to Michaud's office.

ACA is grateful for Congressman Michaud's leadership on this issue. Michaud is a past recipient of ACA's Federal Legislative Service Award, and this most recent letter shows that he is still fighting to expand access to counseling services. During last month's Institute for Leadership Training, ACA Executive Director Richard Yep presented the Congressman's staff with a letter thanking him for his support.

Sadly, since 2006 we have still been shut-out of the process and while the number of veterans seeking treatment has grown, the VA has failed to keep up with the demand for treatment.

Your efforts will help all of us to better understand what the VA is and is not doing in regards to placing counselors in VA facilities, and making them available to returning service members who need help in treating their invisible wounds of war.

We thank you for standing up for counselors and fighting for our veterans. Your work is to be commended and we look forward to working with you on this issue.
